Scholarships to study at The Euro Mediterranean University EMUNI – Piran - Slovenia in the framework of the European Programme ERASMUS+ KA1

Objective

The Erasmus+ Mobility for Studies programme offers students the chance to spend a period of continuous study at **The Euro Mediterranean University EMUNI – Piran - Slovenia** during the second semester of the 2025-2026 within the framework of the Erasmus+ Programme.

Mobility students will receive a grant, can attend courses and use all the facilities available at the University of Aveiro with no additional tuition fees (with the exception of any fees also applicable to local students). All learning activities approved in the Learning Agreement and completed successfully will be fully recognized at the home university.

The Erasmus+ Programme offers students the chance to gain cultural experience abroad, become familiar with other higher education systems and meet young people from other countries, actively contributing to the process of international integration.

The grants offered to Erasmus+ Mobility for Studies students do not cover all the expenses but are merely a contribution to bearing the additional costs of the stay abroad.

The Erasmus+ Programme – mobility for study offers the possibility to spend a period of studies/research at **The Euro Mediterranean University EMUNI – Piran - Slovenia** for **Master (2nd year) students** from the University of Sfax.

Mobility students will be awarded a scholarship, will attend courses and will use all the facilities of the University of Aveiro on an equal basis as the enrolled students.

Financing

Participants are entitled to receive financial support in the form of a grant, based on a signed Grant Agreement before the mobility period, where the amount will be specified, based on travel and individual support.

Calculation and payment of the final amount of the participant's grant is subject to the submission of all necessary supporting documents by the participant, as specified by the individual grant agreement. The category "Individual support" is intended to cover costs directly linked to the subsistence of participants during the activity. In general, the amount of support depends on the country of origin of the student who would go on mobility.

Additional financial support is granted to candidates who consider himself/herself as a participant from disadvantage background. In this case, he/she describes the facts and personal circumstances in a motivation letter. Disadvantage backgrounds are categorized as follows:

- Special needs (physical, mental, intellectual or sensory deficits),
- Health problems (chronic diseases, physical and / or mental conditions that impair functioning),
- Cultural differences (problems of cultural inclusion, especially migrants / refugees, ethical minorities)
- Social barriers (limited social competences, high-risk behaviors, family circumstances),
- Economic barriers (low income, low standard of living, poverty, unemployment, dependence on social protection),
- Barriers to discrimination (gender identity, age, ethical discrimination, religion),
- Geographical barriers (participants from distant and / or less developed areas).

Conditions and procedures

The candidate student must be enrolled at the University of Sfax that signed the Inter Institutional Agreement within the framework of Erasmus + Programme, with **The Euro Mediterranean University (EMUNI)**

The student must be **preselected** and **nominated** by the University of Sfax,

An incomplete application will be considered ineligible.

All the submitted documents must be in English.

The home university will provide a pre-selection of candidates according to the following general criteria:

- Average grade.
- The consistency of the proposed activities.
- Language skills.
- Any other elements indicated by the student in the application (other learning experiences, specific academic interests, etc.).
- Additional criteria i.e: membership in science clubs or associations, participation in conferences and other mobility programmes etc. (it is up to the sending institution to include the criteria or not)
- Students who meet one or more of the following inclusion and diversity criteria established by the Erasmus+ program:
 - disability (i.e. participants with special needs): people with mental (intellectual, cognitive, learning), physical, sensory or other disabilities;
 - educational difficulties: young people with learning difficulties; early school-leavers; low qualified adults; young people with poor school performance.
 - economic obstacles: people with a low standard of living, low income, dependence on social welfare system or homeless; young people in long-term unemployment or poverty; people in debt or with financial problems.
 - cultural differences: immigrants or refugees or descendants from immigrant or refugee families; people belonging to a national or ethnic minority; people with linguistic adaptation and cultural inclusion difficulties.
 - health problems: people with chronic health problems, severe illnesses, or psychiatric conditions.
 - social obstacles: people facing discrimination because of gender, age, ethnicity, religion, sexual orientation, disability, etc.; people with limited social skills or anti-social or risky behaviors; people in a precarious situation; (ex-)offenders, (ex-)drug or alcohol abusers; young and/or single parents; orphans.
 - geographical obstacles: people from remote or rural areas; people living in small islands or in peripheral regions; people from urban problem zones; people from less serviced areas (limited public transport, poor facilities).
