**Prolongation: Scholarships to traineeships at Mardin Artuklu University - Turkey
in the framework of the European Programme ERASMUS+ KA171**

Objective

The Erasmus+ Programme –mobility for study offers the possibility to spend a period of **traineeships** at **Mardin Artuklu University (MAU)– Turkey** for **Bachelor, Master & PHD students** from the University of Sfax (High Institute of Biotechnology of Sfax) Department of Nutrition and Dietetics).

Mobility students will be awarded a scholarship and will use all the facilities of MAU University on an equal basis as the enrolled students.

Student Mobility for Traineeship (SMP)

The activity consists of the project coordinator and the student who is registered in partner higher education institutions, to carry out a professional training at the host institution.

Students have professional experience as a trainee in a related field of their study.

The minimum duration for the mobility is 2 months. Mobility less than 60 days will be ineligible, and all grant is refunded by the beneficiary student.

Students who meet the application requirements can benefit from the activity without grant.

All mobilities are to be Traineeship Mobilities, as part of the project.

Conditions and procedures

General conditions for admittance

The candidate must be a full-time enrolled master student at the University of Sfax that signed the Inter Institutional Agreement within the framework of Erasmus + Programme, with **MAU University – Turkey**

The student must be **preselected** and **nominated** by the University of Sfax.

Pre-selection criteria at the home university

The home university will provide a pre-selection of candidates according to the following general criteria:

- Average grade.
- The consistency of the proposed activities.
- Language skills.
- Any other elements indicated by the student in the application (other learning experiences, specific academic interests, etc.).
- Additional criteria i.e: membership in science clubs or associations, participation in conferences and other mobility programmes etc. (it is up to the sending institution to include the criteria or not)
- Students who meet one or more of the following inclusion and diversity criteria established by the Erasmus+ program:
 - disability (i.e. participants with special needs): people with mental (intellectual, cognitive, learning), physical, sensory or other disabilities;
 - educational difficulties: young people with learning difficulties; early school-leavers; low qualified adults; young people with poor school performance.
 - economic obstacles: people with a low standard of living, low income, dependence on social welfare system or homeless; young people in long-term unemployment or poverty; people in debt or with financial problems.
 - cultural differences: immigrants or refugees or descendants from immigrant or refugee families; people belonging to a national or ethnic minority; people with linguistic adaptation and cultural inclusion difficulties.
 - health problems: people with chronic health problems, severe illnesses, or psychiatric conditions.
 - social obstacles: people facing discrimination because of gender, age, ethnicity, religion, sexual orientation, disability, etc.; people with limited social skills or anti-

social or risky behaviors; people in a precarious situation; (ex-)offenders, (ex-)drug or alcohol abusers; young and/or single parents; orphans.

• geographical obstacles: people from remote or rural areas; people living in small islands or in peripheral regions; people from urban problem zones; people from less serviced areas (limited public transport, poor facilities).

- Proof of Educational Degree - for Master applicants last Bachelor Diploma
- Transcript of Records in English Language showing CGPA score (If not available in English, an official signed and stamped document by the university declaring CGPA is also accepted along with the original document).
- CV
- Certificates of Attendance of the participants' previous Erasmus+ mobility.
- If the participant has any physical disabilities, a document that proves the disability (In English or in original language with an English document from the sending university confirming the authenticity).
- Invitation letter

An incomplete application will be considered ineligible.

All the submitted documents must be in English.
